## **STATEMENT**

Norges Sildesalgslag hereby confirms that the Marine Stewardship Council (MSC) in April 2009 awarded certification of three pelagic fisheries; the species being Norwegian spring-spawning herring, North Sea/Skagerrak herring and Mackerel. This implies that all species as mentioned and caught by Norwegian vessels are *MSC-certified*.

The certification was carried out by an independent certifier and was announced during the European Seafood Expo in Brussels in April 2009.
